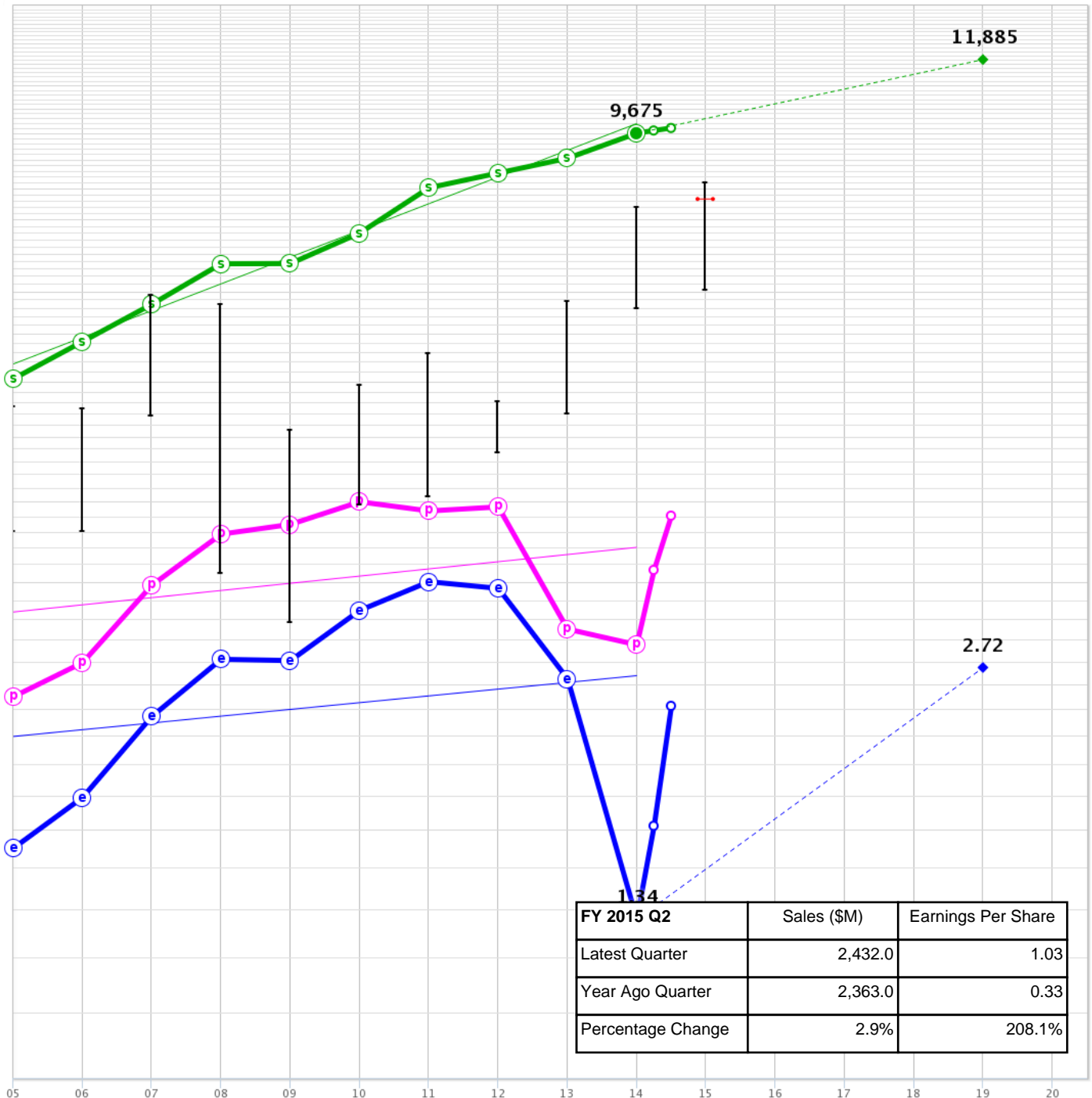

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 41.2 X Estimate High Earnings/Share 2.71 = Forecasted High Price \$ 111.7

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 23.3 X Estimate Low Earnings/Share 1.34 = Forecasted Low Price \$ 31.2

(b) Avg. Low Price of Last 5 Years 53.0

(c) Recent Market Low Price 55.2

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{1.26}{1.99\%} = 63.3$

Selected Forecasted Low Price \$ 31.2

C ZONING using 25%-50%-25%

Forecasted High Price 111.7 Minus Forecasted Low Price 31.2 = 80.5 Range. 25% of Range 20.1

Buy Zone 31.2 to 51.3

Hold Zone 51.3 to 91.5

Sell Zone 91.5 to 111.7

Present Market Price of 100.56 is in the **SELL** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{111.7 - 100.56}{100.56 - 31.2} = \frac{11.1}{69.4} = 0.2$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{111.7 - 100.56}{100.56} = 1.11$ X 100 = 111.03 - 100 = 11.0 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{1.26}{100.56} = 0.01 = 1.4\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{40.7\%}{41.20} = 1.0\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{40.7\%}{32.25} = 1.3\%$

C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E

Annualized Appreciation 2.1 %
Average Yield 1.0 %
Annualized Rate of Return 3.1 %

COMPOUND ANNUAL RETURN - USING FORECAST AVG P/E

Annualized Appreciation -2.8 %
Average Yield 1.3 %
Annualized Rate of Return -1.5 %
