## <u>History of Cornelius Merry 1666</u>

Cornelius Merry was born on 9 November 1666 in Northamton, Hampshire, Massachusetts. Cornelius Merry experienced tragedy when his boyhood home in Northfield was destroyed by the Indians along with the entire town.

About the same time his brother John Merry took up his land in East Hampton, Long Island. Cornelius and his brother-in-law, Thomas Morgan, purchased adjoining farm land in West Hartford, Connecticut, and for the next 100 years there were Merrys on some part of this land or the additional farm just over the West Hartford line in Farmington.

He was married to Bertha or Bethiah Morgan in 1701. They were blessed with ten children.

He died on 7 August 1760.

The following Will of Cornelius seems to have been written by Noah Webster, a name made famous by a later Noah and Daniel Webster. The State Library of Connecticut in Hartford, still had this will on file.

## Will of Cornelius Merry

To the Honorable Court of probates for the District of Hartford, we the Subscribers being Appointed to Distribute the Real Estate of Cornelius Merry Deceased (viz) that part of it which was Given to his Daughters have According to the Order of Court now Given us Distributed to Mary Wells at the West End ten Acres and one half then Next Sarah Cadwell Eleven Acres and one half Butted West on the Aforesaid Land Set out to Mary Wells with the

priviledge of a Road one Rod and a half wide the South Side Acrost the said Mary Well's Land to her Own. Next we Set out to Bethiah Center Eleven Acres Butted West on the Land we have set out to Sarah Cadwell with the Priviledge Afore S,d of Pasing acrost the S,d Sarah Cadwell Land; Next we set out to Leah Hinsdell ten Acres Buted West on the Land we Set out to Bethiah Center with the Afore S,d priviledge of passing Acrost her Land. Next We set out to Lydia Hubard ten Acres butted West on the Land we set out Leah Hinsdale with the Afore S,d priviledge of passing Acrost her Land. Next we Set out to Rachel Turner Seven Acres Butted West on Lydia Hubbards land with the Afore S,d Priviledge of passing acrost her Land Likewise the Priviledge of passing Acrost Rachel Turners Land for all that Ly West of her.

## History of Ebenezer Merry

Ebenezer Merry was born on 1 May 1748 in Hartford Connecticut. He married Sarah Whiting, the daughter of John Whiting, on 5 November 1772. The first three of their children were born in West Hartford, Connecticut.

Ebenezer and his family lived in West Hartford, Connecticut until about 1778. Then they migrated to Kinderhook, New York where the last seven children were born.

The Hartford Land Records Index from 1639 to 1839 show that Ebenezer bought or sold 12 parcels of land from 29 Dec 1786 to 25 Feb 1788.

The Berkshire Middle District Registry of Deeds, Pittsfield, Massachusetts, Book 15, page 521 under the date of 15 August 1783 shows "Ebenezer Merry Gentleman", and "John Whitting Junior", living together, which would mean that brother-in-law John Whitting Junior was living with the Ebenezer Merry family in 1783. Later Ebenezer and his family migrated to Avon, New York, which was than called New Hartford, but as there already was a New Hartford just out of Utica and just over the line from Herkimer County, the name was changed to Avon New York. Here Ebenezer Merry Esq. was named the first Town Supervisor and it was here that Ebenezer owned the Ferry on the Genesee River while a family named Berry had the tavern or Inn on the East bank of the river. For those migrating West who had to cross the Genesee at Avon, the saying was "IF MERRY DOESN'T GET YOU BERRY WILL".

Ebenezer Merry died on 3 July 1809, leaving Sarah who survived him by three years. His son Anson was Executor of his father's Will.

Ebenezer Merry had 2 days service in the town of Hartford,
Lexington Alarm List. He served as a private under Lieutenant
Seymour and Major Newberry in Connecticut Troops.
