

### History of Edward Crow 1641

Edward Crow was christened on 6 February 1641 or 1642 in Alcester, Warwick, England. He was the son of Thomas and Anne Crow. Edward was a miller in Alcester. He married Eleanor Uproberts. This is a patronymic variation of the surname Roberts. Edward died on 15 Nov 1705 at Alcester, Warwick, England.

#### Will of Edward Crow

In the Name of God Amen. I Edward Crow of Alcester in the County of Warwick, Miller, being weake inbody but of perfect mind and memory thanks be therefore giving to Almighty God. Doe make and ordaine my last will and testament in manner following (vizt). Imps I give and bequeath my soule in the hands of Almighty God that gave it and my body I commit to the earth of whence it was, to be decently burryed according to the discesion of my Executor and Executrix hereinafter named. And so for that worldly estate wherewith it hath pleased Almighty God to bless me, I give and dispose thereof as followeth:

Item I give and bequeath unto my son John Crow the sume of one pound one shilling and six pence of lawful English money to be to him paid by my Executor and Executrix hereinafter named within twelve months - next after my decease.

Item I give and bequeath unto my daughter Susannah the now wife of Henry Cole of Alcester aforesaid yeoman the sume of ten pounds of lawful English money to be also paid within twelve months next after my decease.

Item I give and bequeath unto my son William Crow the sume of fifteen pounds of lawful English money to be to him paid within twelve months next after my decease.

Item I give and bequeath unto Mary the daughter of my son John Crow the sume of one pound one shilling and six pence of lawful English money.

Item I give and bequeath unto Mary the daughter of son William Crow the sume of one pound one shilling and six pence of lawful English money.

Item I give and bequeath unto Samuell the son of Elianor the daughter of my son in law Henry Cole and to each of them the sume of one pound one shilling and six pence of lawful English money.

And my mind and will is that the legacies soe left to my four grandchildren shall be paid to the father of each child within twelve months next after my decease.

Item I give devise and bequeath unto my son Edward Crow all that the moiety or halfe parte of all those four tenements of Cottages with the backsides thereto belonging situate and being in Alcester aforesaid in the said County of Warwick in acertaine plaseer street called Worcester street and the back lane leading to the second field there and which said tenements were by me purchased of and from Walter Moore of Alcester aforesaid - - Millwright and the rentor and rentors remaind and remaind thereof. To have and to hold all the said moiety or halfe parte of all the before mentoned four cottages and tenements and premises with their and any of their Appurtences unto my said son Edward Crow his

heires and assignes forever.

Item I give devise and bequeath unto my daughter Mary Crow all that the other moiety of halfe part of all the before mentoned four tenements of Cottages and premises with their and any of their Appurtences herein before mentoned to be purchased by me from the said Walter Moore and the rentor and rentors remainder and remainder there. To have and to hold all the said moiety of halfe parte of all the before mentoned four Cottages or tenements and premises with their and any of their appurtences unto my said daughter Mary Crow her heirs and Assignes forever.

All the rest and residue of my goods and Chattells personall Estate whatsoever, (my debts, legacies and funerall charges being thereout first paid and deducted. I give and bequeath unto my said son Edward and daughter Mary Crow equally to be divided between them. And I doe ordaine, constitute and declare my said son Edward Crow and Mary Crow my daughter Executor and Executrix of his my last will and testament and doe hereby revoake all former will or wills by me at any time heretofore made and doe hereby publish and declare this to be my last will and testament. In Witness wherof I have hereunto sett my hand and seale the seaventh day of November in the fourth yeare of the raigne of our Sovaign (Soverign) Lady Anne Queen of England Anno Dom 1705.
